

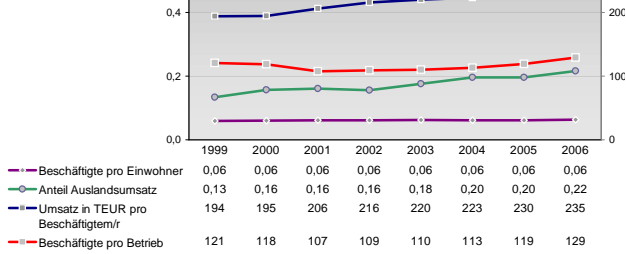

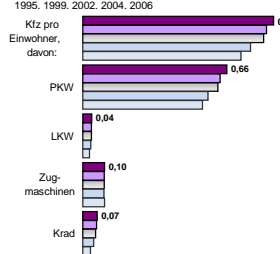

Umsatz und Beschäftigte des verarbeitenden und produzierenden Gewerbes



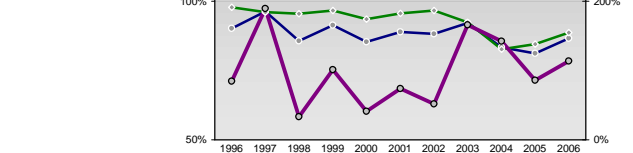
Kfz pro Einwohner



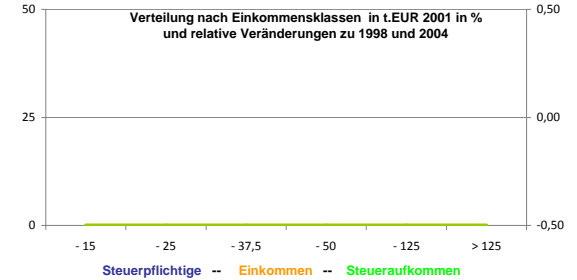

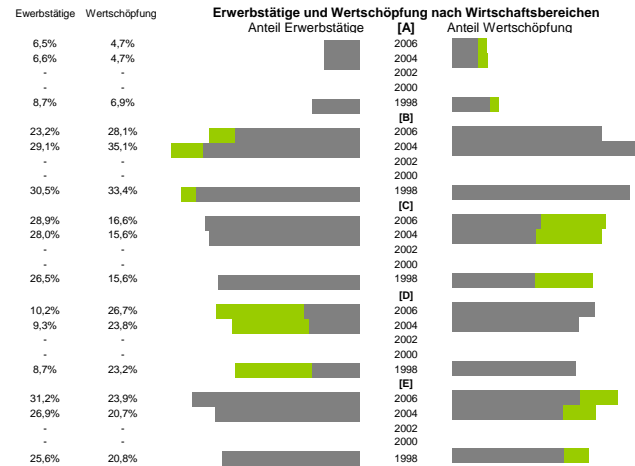

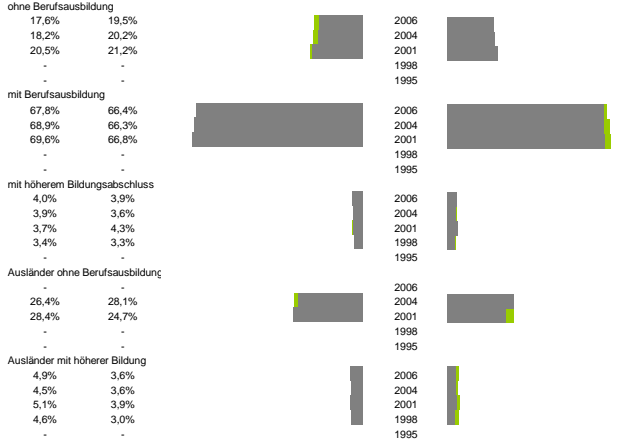
Verteilung nach Einkommensklassen in t.EUR 2001 in % und relative Veränderungen zu 1998 und 2004



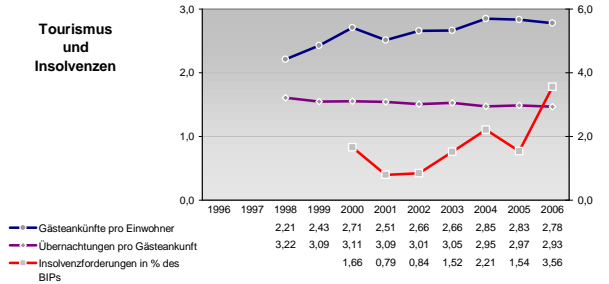
Erwerbstätige und Wertschöpfung nach Wirtschaftsbereichen



Anteile der Soziverspflichtig Beschäftigten am Arbeitsort

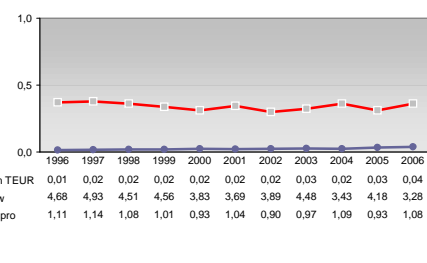
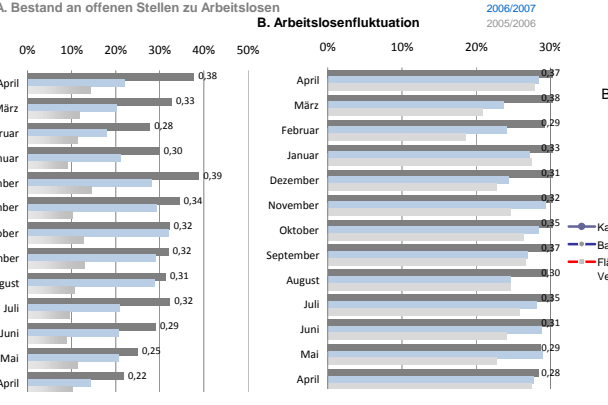
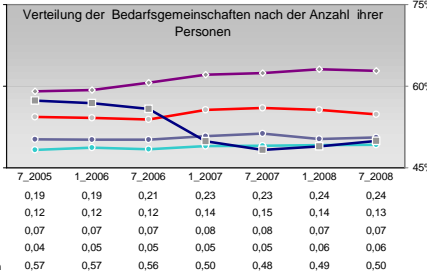
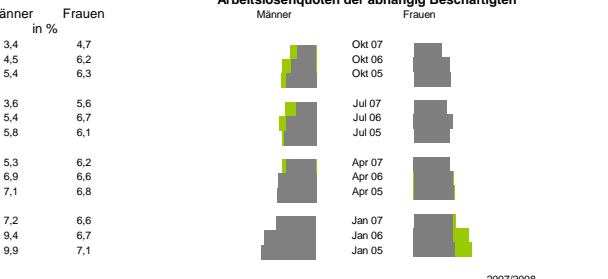
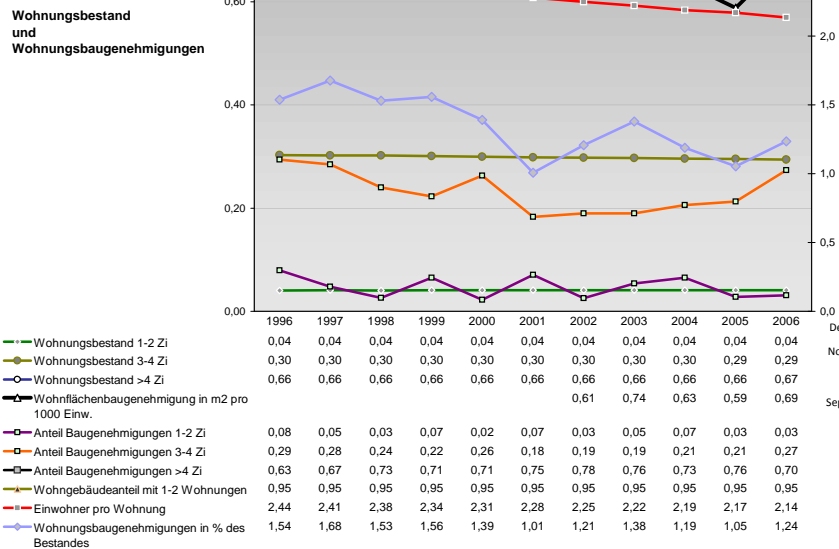
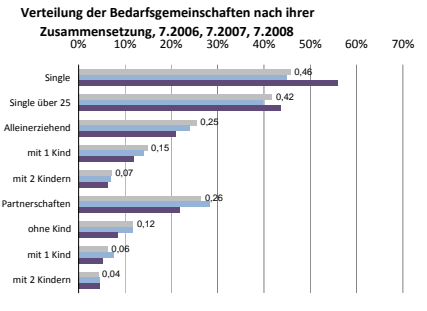
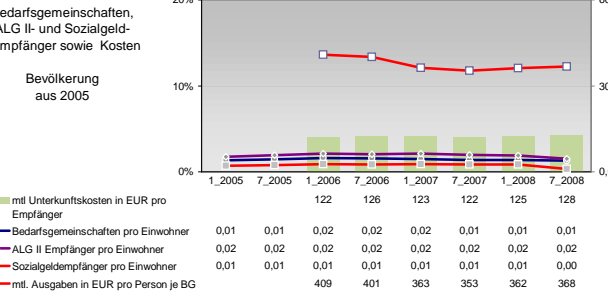
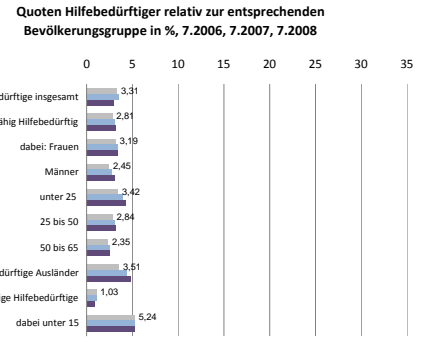
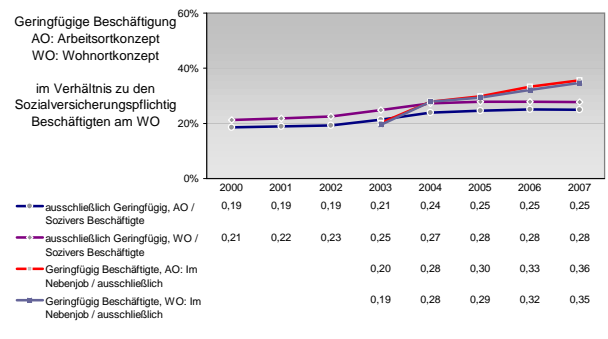
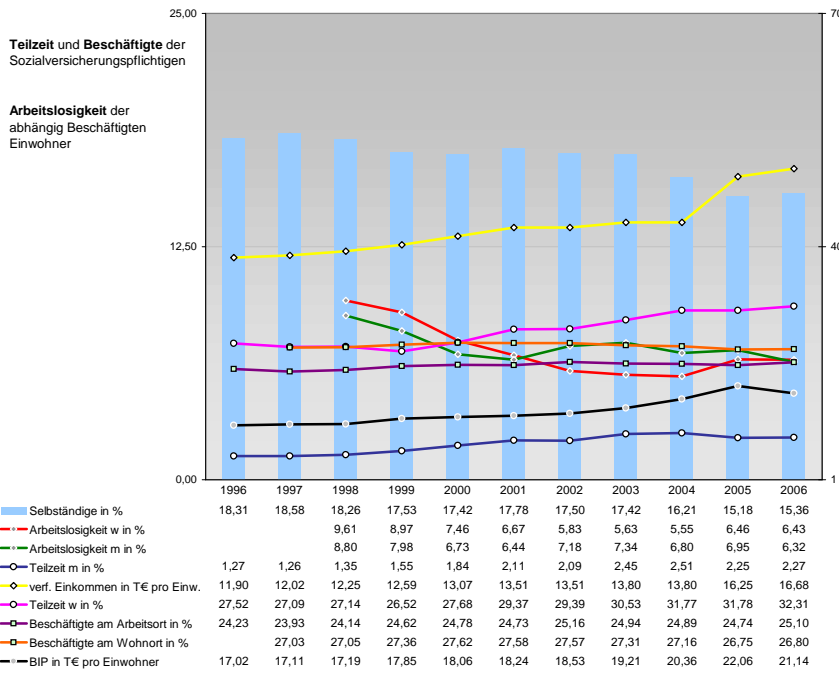
